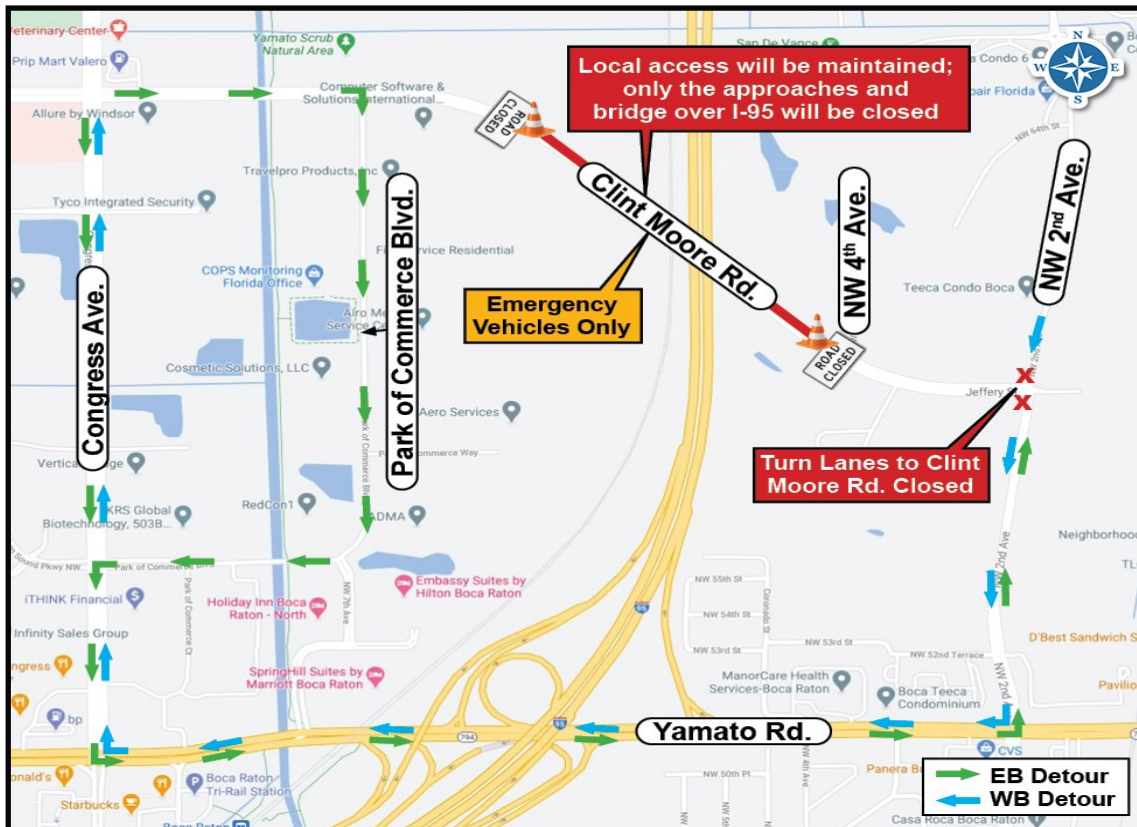
CONSTRUCTION PROJECT NOTICE: BRIDGE CLOSURE

95 EXPRESS LANES PHASE 3B-2 PROJECT

I-95 from south of Glades Road to Linton Boulevard and SR 808/Glades Road from NW 22nd Way to West University Drive, Palm Beach County, Florida

CLINT MOORE ROAD BRIDGE RECONSTRUCTION TO BEGIN MARCH 8, 2021

Reconstruction of the Clint Moore Road bridge over I-95 is anticipated to begin March 8, 2021. To ensure motorist and pedestrian safety, this bridge will be closed completely during construction. Crews are permitted to work 7 a.m. until 6 p.m. Monday through Friday and 8 a.m. until 7 p.m. on Saturday. No work is permitted on Sundays or holidays. Emergency access for first responders will be maintained throughout the duration of the closure. Westbound traffic will be detoured via NW 2nd Avenue, Yamato Road and Congress Avenue. Eastbound traffic will be detoured via Park of Commerce Boulevard, Congress Avenue, Yamato Road and NW 2nd Avenue. Local neighborhood access will be maintained; only the approaches and bridge over I-95 will be closed. The reconstruction of this bridge is anticipated to be completed in Summer 2022 with overall project completion expected in late 2023.



The 95 Express Lanes Phase 3B-2 project will extend the existing Express Lanes north from just south of Glades Road to south of Linton Boulevard in Palm Beach County. One lane will be added and the High Occupancy Vehicle (HOV) lane will be converted to create two Express Lanes in each direction; the number of General Use lanes will remain the same. Access to the Express Lanes will be provided via two designated ingress and egress locations between Glades Road and Spanish River Boulevard and between Yamato Road and Linton Boulevard. The scope of work includes reconfiguration of the SR 808/Glades Road Interchange to a Diverging Diamond Interchange (DDI).
